In conjunction with Pulaski County hiring policies, all employees, volunteers, coaches and other workers are subject to a basic criminal background check. (A criminal background check is performed by simply giving your name and social security number.) In an effort to protect the legal interests of the County of Pulaski, those denying the County to conduct a basic criminal background check will not be considered for volunteer service. The County Recreation Commission reserves the right to terminate anyone performing volunteer service for any conduct deemed as inappropriate.
